POTENTIAL HEALTH EFFECTS (See Section 11 for toxicological data.)

EYE: May cause slight temporary eye irritation. Corneal injury is unlikely.

SKIN: Has caused allergic skin reactions in humans. Prolonged exposure not likely to cause significant skin irritation. Prolonged skin contact is unlikely to result in the absorption of harmful amounts.

INGESTION: Low toxicity if swallowed. Small amounts swallowed incidental to normal handling operations are not likely to cause injury; however, swallowing larger amounts may cause injury.

exposures to low molecular weight epoxy resins of this type are not anticipated to cause any significant adverse effects.

CANCER INFORMAITON: Many studies have been conducted to assess the potential carcinogenicity of diglycidyl ether of bisphenol A (DGEBPA). Although some weak evidence of carcinogenicity has been reported in animals, when all of the data are considered, the weight of evidence does not show that DGEBPA is carcinogenic. Indeed, the most recent review of the available data by the International Agency for Research on Cancer (IARC) has concluded that DGEBPA is not classified as a carcinogen.

TERATOLOGY (BIRTH DEFECTS): DGEBPA did not cause birth defects or other adverse effects on the fetus when pregnant rabbits were exposed by skin contact, the most likely route of exposure, or when pregnant rats or rabbits were exposed orally.

REPRODUCTIVE EFFECTS: In animal studies, DGEBPA-based epoxy resins have been shown not to interfere with reproduction.

#### 4. FIRST AID

EYES: Flush eyes thoroughly with water for several minutes. Remove contact lenses after initial 1-2 minutes and continue flushing for several additional minutes. If effects occur, consult a physician, preferably an ophthalmologist.

SKIN: Wash skin with plenty of water. Items which cannor be decontaminated, including leather articles such as shoes, belts, and watchbands should be disposed of properly.

INGESTION: If swallowed, sack medical attention. Do not induce vomiting unless directed to do so by medical personnel.

INHALATION: Move person to fresh air; if effects occur, consult a physician.

NOTE TO PHYSICIAN: Consider additional thorough skin wash with mild non-abrasive soap and plenty of warm water for at least 15 minutes. No specific antidote. Treatment of exposure should be directed at the control of symptoms and the clinical condition of the patient.

10. STABILITY AND REACTIVITY

CHEMICAL STABILITY: Thermally stable at typical use temperatures.

CONDITIONS TO AVOID: Avoid temperatures above 350C, 662F. Potentially violent decomposition can occur above 350C, 662F. Generation of gas during decomposition can cause pressure in closed systems. Pressure build-up can be rapid.
